I have 3 days upon notification of completion to pick up my boat, if previous arrangements with Rex have not been made. I agree to pay daily storage rate of 50-cents per foot for land storage or \$2.00 per foot for in-water boats remaining 3 days after notification.

Be sure any existing balance has been paid. We can not schedule or initiate a work order until all past due bills are paid in full.



Leave a key, lock combination, or key hiding place. To expedite your service, we must have a set of keys (or combination) available before scheduled work can begin. There will be a \$25 service fee assessed if no key is provided at the time of servicing.

Lines and fenders of appropriate length and size must be on board for launch and will be supplied and charged to my work order if necessary. Shore electrical power cord is needed prior to work commencing if boat is so equipped.

Remove Your Boat and Trailer ASAP. We do not provide storage for trailers and can not be responsible for trailers left in the yard. Trailers left behind will be moved offsite and assessed daily storage charges.

Leaking Boats. Owners are responsible for leaking boats whether or not they are present at launch. Of course, Rex employees will make reasonable efforts to assist leaking boats at prevailing rates.

Update and sign the credit card authorization. Your credit card number must be supplied to facilitate payment. Writing "On File" is not accepted and may cause delays. Payment in full is due upon completion of your work order. We will mail your invoice upon completion. We may charge your unpaid balance to your credit card within six days of the postmark on your invoice unless you make other arrangements. Charges will be posted to your card immediately if your boat is removed prior to payment.

INFLATABLE REPAIR SERVICE

1. Boats must be less than 10 years old for a successful, GUARANTEED repair due to fabric deterioration.
2. Boats must be clean, bottom un-fouled and folded at drop off, CLEANING FEES will apply if necessary.
3. Floorboards, wooden seats, pumps, and other accessories must be removed before drop off. Rex does not store these items.
4. Boat bag and/or inflated seat/thwarts must be logged in if they are left with the boat.

EVALUATION FEES: (Charged even if repair work is declined)

\$One Hour Minimum for soft bottom less than 11 feet \$125 for rib (hard hull) and 11 feet and longer

All evaluation requests are based upon 30 Point Evaluation and may be adjusted if hidden problems appear.

Soft bottomed boats remaining 7 days after notification of completion will incur storage fees at \$25.00 per week. Hard Hull (RIB) or on trailer boats will incur storage fees at \$3.00 per foot per week after one week.
